Subject: Stateline Road Pedestrian Project – TIP #MS-LSTP-2015-04

Dear Ms. Moore:

The Memphis MPO has determined that the requested Adjustment #11 to the FY 2017-20 Transportation Improvement Program (TIP) meets the criteria to be processed as an administrative adjustment and not as an amendment. As a result, there was no public notice of the changes and no vote by the Transportation Policy Board to approve the changes.

The City of Southaven has requested to adjust the Stateline Road Pedestrian Project, TIP #MS-LSTP-2015-04 in the FY 2017-20 TIP. The adjustment is to add ROW to FY 2018 and increase the funding amount for PE in FY 2017. It was determined that right-of-way acquisition is needed, which was not included when the project was originally programmed into the TIP. The total funding programmed for the project will not increase, but instead be redistributed between the PE, ROW, and Construction phases as indicated on the TIP page. Additional funding will be needed to complete construction. The change is for an existing TIP project, the adjustment does not change the project scope, and the funding changes meet the thresholds established for an adjustment under the Memorandum of Agreement between MDOT and the MPO. Since the TIP is a subset of the 2040 RTP then air quality conformity determination made on the RTP applies to the TIP (40 CFR 93.122).

The Memphis MPO has made the requested adjustment to the FY 2017-20 TIP to accurately reflect the requested changes. It is the request of the Memphis MPO that the TIP project changes be amended into the State of Mississippi Statewide Transportation Improvement Plan. Attached to this letter are the old and newly adjusted TIP pages.

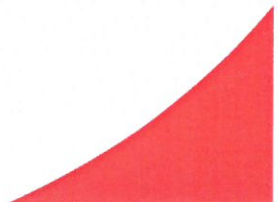

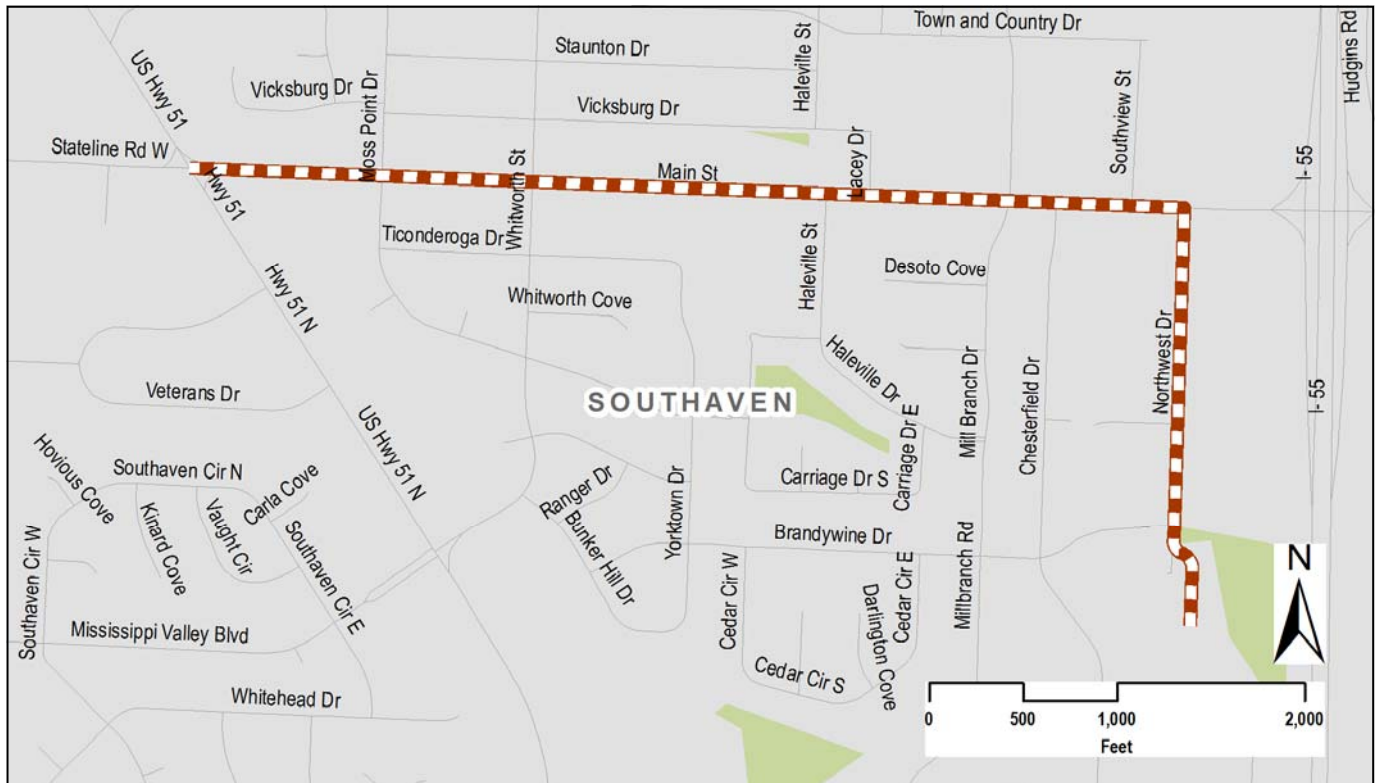

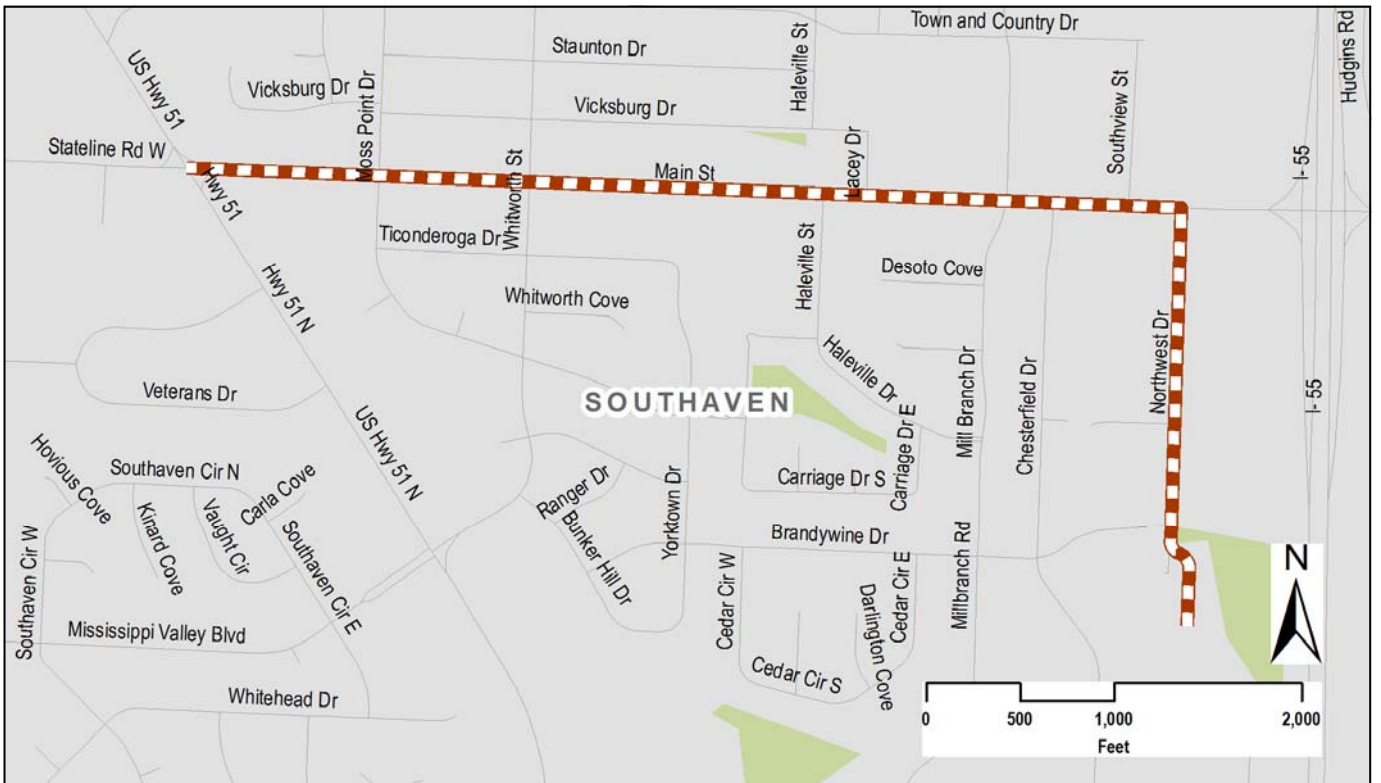
