MATA Section 5310 Updates

- FY 2022 Fund: Grant TN 2016-025 5310: \$14,556 for same day service for MATAPlus, MATA staff time, and a bus inspection for 5 Ford Transit vans
- FY 2022 Fund: Grant TN 2016-025 5310: \$748,656 for 8 replacement Ford Transit Vans, \$187,164 for 2 expansion Ford Transit Vans, \$5,200 for bus inspection for 10 Ford Transit vans (totaling \$941,020)
- **Overall (Federal) for FY 2022: \$955,576**
